EU POLICY UPDATES

New energy efficiency target proposed by the European Commission: On 23 July, the European Commission proposed to increase the energy efficiency target to 30% by 2030. Member States will have to decide whether or not to endorse the target in the upcoming Summit, set to take place in October 2014 and to include them as part of the 2030 Energy and Climate Package. The 2030 targets are the successors of the “20-20-20 targets” and propose a mandatory reduction in greenhouse gas (GHG) emissions of 40% below the 1990 level and an EU-wide target for renewable energy of 27%. The European Council is expected to agree on the 2030 climate and energy targets in October 2014. For more information, please [click here](#).
