The aim of this must-read report is to summarise recommendations for R&D topics based on the user community's needs and requirements, as well as energy policy targets. The report is intended to be a living document revised on a biennial basis. In accordance with this, the growing importance of Systems Integration and Energy Storage is now addressed in a dedicated chapter that reviews overall performance improvements that can be obtained by the integration of gas turbine technology in other systems. DECENTRALISED ENERGY SYSTEMS WORKING GROUP - LAUNCH MEETING

The aim of ETN's new Decentralised Energy Systems Working Group is to bring together stakeholders of the value chain for decentralised energy solutions involving micro and small gas turbines, with the objective to accelerate the development of cost-efficient integrated secure technology solutions in line with the market needs. The first part of our virtual launch meeting will be organised on 23 September, followed by the second part of the meeting on 28 September. These meetings are open to all ETN members. GAS TURBINE ENCLOSURE STANDARD FOR HYDROGEN FUEL

During our AGM & Workshop earlier this year, ETN members initiated discussions about gas turbine enclosure for hydrogen blends or pure hydrogen. As it was highlighted during ETN's event, currently there is no standard addressing enclosure safety challenges for gas turbines running on hydrogen fuel mixtures. The participants decided to launch a taskforce under ETN's Hydrogen Working Group to gather perspective from the whole value chain, in order to understand and agree on how to safely design the enclosure. The launch meeting of the taskforce, open to all ETN members, will be held virtually on 10 September. You can register for the meeting by clicking here. EU INDUSTRIAL EMISSIONS DIRECTIVE

Under the <u>European Green Deal</u>, the European Commission will propose a revision of EU measures addressing pollutant emissions by large industrial and (agro-) industrial plants. The review aims to support EU's goals on zero pollution, climate neutrality, biodiversity and a cleaner, more circular economy. ETN is a member of the Industrial Emissions Directive (IED) Forum and attended the recent stakeholder workshop "Assessment of options for the revision of the Industrial Emissions Directive" in July, during which the latest developments were presented to the stakeholders of the Forum. The final report is expected to be released in autumn 2021, and the legislative proposal for revision of the IED shall be published in early 2022.
